**Extracts from the first recorded meetings of the Original Minute Book 1926 - 1951**

Annual Meeting of the Hunter River Golf Association held at Singleton, September 16th, 1927.

Present: Messrs Scobie & Tipper representing Maitland Club,  
Messrs Nowland & Swaddling representing Muswellbrook Club,  
Mr Fitzhardinge representing Singleton Club and  
Mr Swaddling representing Scone & Merriwa clubs as proxy.

Election of Office Bearers.

Mr Tipper proposed and Mr Scobie seconded, "That Mr J H Bettington be re-elected President". There being no further nominations the chairman,

Mr W H Nowland was elected to preside in the absent of the President,

declared Mr J H Bettington unanimously elected President.

Mr Tipper and Mr Swaddling seconded, "That the Presidents of all affiliated Clubs be Vice Presidents of the Association." Carried.

Mr W R Nowland elected Hon. Secretary on the motion of Mr Tipper, seconded by Mr Fitzhardinge.

Mr W R Nowland elected Hon. Treasurer, moved by Mr Tipper and seconded by Mr Fitzhardinge.

Messrs J H Bettington and A W Swaddling were elected as Delegates to the Suburban Golf Association, on the motion of Mr Nowland, seconded by Mr Tipper.

The Captains of the Scone, Singleton and Maitland Clubs were appointed as a committee to govern the teams matches for this year.

On the motion of Messrs, Fitzhardinge & Swaddling, it was decided that a Banking Account be opened with the Rural Bank at Muswellbrook.

Mr Swaddling moved and Mr Fitzhardinge seconded "that the Hon. Treasurer and Hon. Secretary operate on the account." Carried.

The Hon. Treasurer declared the present Credit balance of Thirty Five pounds, fifteen shillings and three pence.

Mr Fitzhardinge moved and Mr Swaddling seconded, "THAT THE LIMIT FOR HANDICAPS OF ALL MEMBERS OF ALL AFFILIATED CLUBS SHALL BE 27/18. Carried.

Mr Fitzhardinge moved and Mr Tipper seconded: "THAT HANDICAPS BE ARRANGED BY TAKING THE AVERAGE OF THE BEST THREE CARDS RETURNED IN COMPETITION. THE HANDICAP TO BE TAKEN FROM PAR OF THE COURSE PLUS SIX FOR EIGHTEEN HOLES." Carried.

Gentlemen,

In presenting the Annual Report for the season, 1927 - 28 the Association cannot be congratulated on it's activities, this should not be, there is no reason why the Association should not be a very live body and make itself felt in the world of golf, it only remains for the officials and the various Clubs to take an active part in the affairs of the Association and this very much desired state of things will be brought about.

Country Week. No team was entered nor an effort made to enter one for the Country Teams Championship last year, the previous year your Association's team ran a good second and with organisation our best team should be available and we should win the Country Championship, it is hoped that in future a team will be entered and more interest taken in the competition.

Finance. The Association is in a good position, the Hon-Treasurer, Mr W H Nowland's Balance Sheet which will be read to you shows a credit of "forty two pounds, nine shillings and one penny.

Club Championship This event was again won by the Muswellbrook Club, the final being played against Branxton, the cup presented by the President, Mr J H Bettington for this event is a very handsome one and is held for the time being by the winning Club. By some of the Clubs taking part this competition does not seem to be looked upon with the importance it demands, 54 players are engaged in the matches and it will be realised that this must be good for the game from a playing point of view, it encourages the men to excel and strive to take part in the games and considerably helps to increase the good fellowship that exists between the Clubs at the present time, it is suggested that a set of rules be drawn up for this competition.

Championship Meeting. So far no meeting has been held by the Association for the championship, last year it was cancelled at the last moment, in future an effort should be made to make this event the most successful in the season for the Association, it only remains for the various Clubs to put their shoulders to the wheel and the meeting will be crowned with success.

### **Secretary's Annual Report, 1935.**

Gentlemen,

I am pleased to present the 8th Annual Report for adoption.

The following clubs are now affiliated with the Association:-

Singleton, Branxton, Maitland, Kurri Kurri, Cessnock, Morpeth, Dungog and Gloucester. I regret to report that the following 6 clubs have withdrawn to try and form another

Association, Murrurundi, Scone, Aberdeen, Muswellbrook, Denman and Merriwa. Possibly they will not get affiliation with the Suburban and Country Golf Association. Until they get affiliation none of their members can take part in any open competitions held by affiliated clubs, and members of affiliated clubs cannot take part in their competitions. Should they ask us to take them back or give them affiliation as a sub-district. I recommend that their request be granted.

The Treasurer's Report shows we have a credit balance of seven pounds, seven shillings and one penny and twenty five pounds on Fixed Deposit due 23/8/36.

The Championship Cups authorised by last Annual Meeting have been purchased and all cups belonging to the Association have been engraved up to date.

Owing to the withdrawal of some of the clubs from the Association the rules of the inter-club matches will have to be revised.

This year the Bettington Cup was played in two zones. In the Southern Zone, Cessnock entered two teams thus dividing their strong team to make the competition more interesting. I hope they do the same this year. This made 7 teams in this zone, the committee decided to play it in two sections. The two Cessnock teams met in the final of this zone.

Cessnock again won the Cup defeating Muswellbrook in the final of the two zones.

The Pogonoski Cup was played in two zones, Gloucester winning the Cup from Muswellbrook in the final of the two zones. All games were keenly contested and have done much to improve the game generally. I would like to see every club enter a team or teams in these competitions.

The Championship meeting was held at Maitland, and the Secretary and Committee are to be commended on the order of their links and the way they ran the meeting.

The Championship was won by S.D. Searston of Branxton Club with an aggregate of 156 for 36 holes. K K Tulloch was runner up with 157.

The Mixed Foursome Championship was won by Mr & Mrs H L Sargeson of Cessnock Club with a splendid round of 85 off the stick. K K Tulloch and Miss K Tulloch were the runners up with 88.

The Associate Championship was won by Miss K Tulloch of Cessnock.

The T.B. Cup was won by W Johnstone of Kurri Kurri Club. Although the entries for this cup were better than last year they are still not good enough. I will not be satisfied until every club takes part in it.

The Association was again represented in the teams match at Country Week, but unfortunately we were not strong enough. I hope we will be again represented this year and with our strongest team.

If the Secretaries of the various affiliated clubs answer my letters as soon as possible they will save me a lot of unnecessary work. I do not think there was one club that I did not have to write to for replies to my letters of results of their matches and some of them I had

to write to twice. If I took as much interest in the Association as apparently some of them do, its affairs would be in a mess.

A new set of rules for the Association have been drawn up based on the rules of the Suburban & Country Golf Association and our old rules which will be submitted for your approval at the Annual Meeting.

**Secretary's Report for 1936.**

Gentlemen,

I am pleased to present the 9th Annual Report for adoption.

The following clubs are now affiliated with the Association, Singleton, Branxton, Maitland, Morpeth, Dungog, Gloucester, Kurri Kurri and Cessnock.

Your Executive Officers offered to meet the clubs that withdrew last year to try and arrange for them to rejoin the Association, but so far we have not heard from them. We have had alterations to our rules, to allow the Association to affiliate Sub-district Associations drawn up for submission to this meeting.

The Treasurer's Report shows we have a credit balance of twenty four pounds, thirteen shillings and two pence made up as follows: Current balance of twenty four pounds, thirteen shillings and two pence: made up as follows: Current Account four pounds, thirteen shilling and two pence.

Fixed Deposit twenty pounds due 23/8/37.

I would suggest that the meeting consider requiring the club on whose links the Championship meeting is held to guarantee to pay the Association at least six pounds, this will just about cover the replicas and engraving.

The Bettington Cup was again won by Cessnock, after keen competition between 5 teams, viz. Cessnock 1, Cessnock 2, Maitland, Singleton and Gloucester.

The Pogonoski Cup was played in two divisions 4 teams in each, viz, Cessnock, Kurri, Branxton and Singleton. Branxton won this division having to play a final match against Kurri at Maitland. Maitland, Morpeth, Dungog and Gloucester in the other division where Dungog was the winner. Branxton and Dungog played home and home matches and as they were still equal to 3, four of the individual matches at Maitland where Dungog won by 6 matches to 3, four of the individual matches finishing on the last green. Playing these matches on handicap will encourage these players to improve their golf and eventually get into the Bettington Cup.

The Championship was held at Cessnock, unfortunately I was away from the district when it was played. The Championship was won by Mr F G Young of Cessnock Club, the Mixed Foursomes by Mr K Tulloch and Miss K Tulloch of Cessnock Club.

The T B Cup by Mr H A Horton of Branxton Club, the Teams Match by Cessnock (Mr F H Lindeman's team) and the Associates' Championship by Miss K Tulloch of Cessnock Club.

It has been suggested to me that the Association conducts a "B" grade Championship for players on handicaps of 15 and over. I think this would be a financial success as well as giving interest to the long markers.

I have to thank the secretaries of affiliated clubs for their assistance in answering my letters and sending me the results of the matches, and hope they will carry on the good work.

During the year I attended open meetings at all the affiliated clubs except Gloucester, unfortunately, I was unable to get away for their meeting.

### **Minutes of the Annual Meeting held at the "Criterion Hotel" Singleton 18th February, 1939 at 8 pm.**

Obituary: Before the commencement of the formal business of the meeting the President, Mr K O Warburton made reference to the death of Mr F H Lindeman, (Cessnock), and Mr P Truscott (Muswellbrook) both of who had been prominent in the affairs of the Association.

At the request of the President the delegates stood in silence for a moment as a mark of respect and regret at the passing of these former stalwarts of the Association.

New Affiliations: The provisional affiliation granted to Stroud and Paterson Clubs was confirmed on the motion of Mr Brownie seconded by Mr Bercini.

F G Lindeman Cup: The President again made reference to the death of Mr F H Lindeman and to his long and valuable services to the Association and he suggested that to perpetuate the late Mr Lindeman's memory a Cup should be provided by the Association for perpetual competition at the Annual Championships meeting.

The President then moved that the services of the late Mr F H Lindeman should be recorded and in order to perpetuate his memory a cup should be purchased to be played for each year at the Championship meeting for the 36 hole handicap event, the winner to hold the Cup for one year and to receive a replica to be provided by the Club holding the meeting.

This was seconded by Mr C Fitzhardinge, Hon. Secretary, who also expressed his appreciation of the late Mr Lindeman's services, and carried. Mr Clarke said that the Cessnock Club was grateful to the Association for thus honouring its former President.

Mr C Fitzhardinge: The President referred to the services of Mr Fitzhardinge as Hon. Secretary of the Association. He said that Mr Fitzhardinge had been the first or second Honorary Secretary and after an absence from the district of some years was again made Hon. Sec. on his return. He moved that the good services of Mr Fitzhardinge and the Association's appreciation of all he had done for golf should be recorded. This was seconded by Mr Joughin and carried.

A vote of thanks to the Chairman was carried by acclamation and the meeting closed at 11 pm.

### **Hon. Secretary's Report for 1939 Season to be presented at the Annual Meeting, Saturday, 24th February, 1940.**

Gentlemen,

This is the 12th Annual report of the Association and the first which I am presenting.

Since the last Annual Meeting our country has become involved in a war, the course or duration of which none of us can foretell. Whether that fact is to limit our curtail the activities of the Association is a matter of concern to us as golfers, who must consider whether any national duty does or should interfere with our normal working as an Association and our programme for the coming season. In my opinion it does not. The year we are concluding has been a successful one in many respects.

Gloucester, Stroud, Dungog, Paterson, Morpeth, Raymond Terrace, Maitland, Kurri Kurri, Cessnock, Branxton and Singleton and the Upper Hunter Sub-district comprises Merriwa, Denman, Murrurundi, Scone, Aberdeen and Muswellbrook.

The affiliation fees were as follows:- Association Clubs - 430 members. Ten pounds, fifteen shillings. Sub-district Clubs - 197 members. Four pounds, Eighteen shillings & six pence, plus three pounds, three shillings.

The Association team won the District Teams Championship at Country Week with the following team:- DR Lysaght (Captain) and R Linsley (Murrurundi) R McGregor (Muswellbrook), N Lloyd (Singleton), J Bercini (Branxton) H G Cobley and K K Tulloch (Cessnock).

This was possibly not the strongest team available but no selected team could have played its part better, and the final match which resulted in a 7-0 victory for the Hunter River Association team was a wonderful finale. The Cup presented by Hardy Bros. is being circulated among the Clubs whose members made up the teams, and miniature copies also presented by Hardy Bros. have been forwarded to the members of the team.

As the result of a happy suggestion by Mr Warburton during the season matches were arranged between teams representing this Association and the Newcastle District Golf Association.

In approving of the suggestion and arranging the matches the Executive had in mind two objects, namely practice for the Country Week team and also the fostering of relations between the two Associations. In this connection it might be remarked that at some future time similar matches could be arranged with other adjoining Associations, but for the present the idea of Inter-district matches with the Newcastle District Association. Interest would be added to these matches if pennants were provided for the competition once the matches became regular fixtures.

Bettington Cup - The Bettington Cup competition gave the Cessnock Club another opportunity of demonstrating its supremacy in the Association. Its team only sustained one defeat and it was then not at full strength. For the final against Muswellbrook, the winning Club in the Sub-district, it was decided to play home and home matches and after winning the match at Muswellbrook 5-4, Cessnock was beaten at home by the same margin, however, a final match played at Singleton was won by the Cessnock team and I have pleasure in congratulating the Club on maintaining its record of so many successive wins.

Pogonoski Cup The struggle for the Pogonoski Cup was very keen. The draw in the Association was made in two zones, the zone winners being Branxton and Raymond Terrace. These Clubs played home and home matches and each won its home match 5-4. A final match was then played on the Maitland course by courtesy of the Club and Raymond Terrace won this match. Two zones were also played in the Sub-district and the final between Merriwa and Scone was played on the Denman course, resulting in a win for the Merriwa Club, which subsequently defeated Raymond Terrace in the final on the Muswellbrook course. Merriwa is to be congratulated on its first win in this event and it might not be out of place to add that on its performance the Club might consider playing in the Bettington Cup next year.

I would like to express the thanks of the Association to the Club who have made their courses available for these final matches, and in the case of the Maitland Club for the inter-Association match as well.

Obituary. It is with great regret that the death is reported of Mr R Dixon, a member of the Kurri Kurri Club who was killed while returning from a match at Cessnock, and Mr A A H Christie, former Hon. Secretary of the Cessnock Club, whose death was reported only a few weeks ago.

I have to thank those Club Secretaries who assisted me during the year by promptly answering letters and supplying teams and results where necessary; and I am glad to say that apart from my complaint in the matter of handicapping there were only one or two who did not help me in this respect. I hope that Club Secretaries will always remember that the Association Secretary depends largely on them and that their co-operation is essential to the proper carrying out of his duties.

#### **Minutes of A Special General Meeting held at the Club House of the Singleton Golf Club on Monday, 17th June, 1940 at 5 pm.**

Present: Messrs. K O Warburton in the Chair; J Bercini, Branxton, N E Clarke, Dr W A Conolly and Dr T R Street, Cessnock, J J Johnstone & G Lavender, Kurri Kurri, J Brownie & W F Norris, Maitland and at a later stage C H Dunlop, Singleton.

The Chairman announced to resignation of Mr N A Lloyd from the office of Hon. Treasurer and moved that Mr W A Low of Singleton should be elected in his place.

This was seconded by Mr Brownie and carried.

The Chairman reported that the Associates of the Singleton Club had decided not to conduct the Associates' Championship owing to the war position but that if it was thought desirable to hold this Championship the Singleton Club would conduct it. It was decided on the motion of Dr Conolly, seconded by Mr Brownie, to refer the matter to the Associates of the affiliated Clubs and to act in accordance with the desires of the majority.

On the motion of Dr Connelly, seconded by Mr Bercini, it was agreed to cancel all Association fixtures for the year. On the motion of Mr Brownie, seconded by Mr Bercini, it was decided that the Association should hold an Open Tournament of 4th August at Maitland, the proceeds to be given to the Commonwealth Government for war purposes; that a competition of 27 holes be conducted and that each affiliated Club be asked to provide one trophy.

#### **Hon. Secretary's Report for 1940 Season to be presented a the Annual Meeting on 15.2.1941**

Gentlemen,

This is the second report which I have had the honour of presenting to the Association.

It records what is perhaps the smallest activity in the Association's 14 years of existence.

At a special general meeting held at the conclusion of the annual tournament, it was decided that in view of the critical war situation and of the decision of the N.S.W Golf Council to suspend inter-club competitions, the Bettington and Pogonoski Cup matches should be abandoned. Country Week was not held, so that the Teams' Championship Cup won in 1939 is still held by the Association. No inter-district match was played.

Affiliation The following clubs were affiliated: Gloucester, 17 members, Stroud 20, Dungog 31, Paterson 18, Raymond Terrace 13, Morpeth 42, Maitland 58, Kurri Kurri 68, Cessnock 116, Branxton 25 and Singleton 67, a total membership of 475 compared with 430 in 1939. The number 475 of course represents 1939 membership as the affiliation is based on the previous year's figures. The sub-district affiliation has not yet been paid, though I am advised by the Hon. Secretary that this will be done.

Association Championships. The Championship Tournament held at Singleton was not a great success. Entries were disappointing, but in the circumstances this cannot be taken to indicate a lack of interest in Association events. The failure of the Singleton Associates to conduct the Associates' Championship caused much disappointment. The question has never previously arisen, but now that it has it is considered that the Club holding the Championship Meeting and not the Associates of that Club should be made responsible for the conduct of the Associates' Championship.

Patriotic Tournament A highly successful "War Fund" Tournament was held at Maitland on 4th August, the proceeds being given to the Commonwealth Government for war purposes.

I was unable to attend or even to devote any time to the organisation of the effort, and most of the work devolved on Mr J Brownie of Maitland, to whom much of the success of the tournament was due. Although not fully supported by all clubs, and a very great disappointment in this respect, the tournament yielded a sum of One Hundred & Seven pounds. The initial contributions of Cessnock, Five pounds five shillings, Gloucester, Five pounds, Maitland Five pounds five shillings and Singleton Five pounds five shillings are worthy of special mention, as is the provision by the Maitland Club of all the facilities for the tournament.

The New South Wales Golf Council has appointed 9th August for a state wide patriotic drive, presumably a day for individual Clubs - but it is felt that another successful Association effort might be made in the coming season.

Finance. The Hon. Treasurer, N Lloyd, Singleton, report indicates a satisfactory financial position. It was thought last year that it might become necessary to increase the capitation fee for one year, but this has been avoided for the present.

In Conclusion I desire to thank Mr T Patterson for his very active support on the Handicapping Committee; also the Hon. Secretaries of the various Clubs for their support and co-operation.

TOTAL 401

The Association's Opening Day held at Singleton was not very well attended and I consider that this day should be abandoned as well as the championship meeting.

The Bettington and Pogonoski cup competitions were played but much of the interest usually attaching to this inter club series was missing. The strong Cessnock and Maitland Clubs did not enter either competitions, preferring to concentrate their activities on the raising of funds for war and patriotic purposes, and apart from this factor there was a noticeable lack of keenness which no doubt was due to the war situation.

Three Clubs, Branxton, Singleton and Kurri Kurri took part in the Bettington Cup competition and five in the Pogonoski Cup. Kurri Kurri won both competitions and must be congratulated on this performance. I think it will be unanimously agreed that these competitions should not be resumed until after the war.

The patriotic tournament conducted for the Association by the Cessnock Club was a woeful failure as an Association effort, but a great individual triumph for the Cessnock Club.

Only one other Club can be said to have supported the tournament whole-heartedly and in view of this the sum of ninety pounds five shillings and six pence realised was very good indeed.

The generous donations of five pounds five shillings each by the Cessnock, Maitland and Singleton Clubs, two pounds two shillings by Branxton, one pound one shilling each by Kurri Kurri and Raymond Terrace with donations from Maitland, Kurri Kurri & Singleton Associates of two pounds, two shillings - one pound ten shillings and one pound one shilling respectively made a total of one hundred & fourteen pounds seventeen shillings and six pence of which one hundred & eleven pounds eighteen shillings and three pence was distributed.

In conclusion I should like to express the hope that all the Clubs carrying on will devote their full energies to assisting the war effort in some way.
